The Zenmuse XT is currently compatible with the following DJI Aircraft: Inspire 1, Inspire 1 v2.0 and Matrice 100. It will also be compatible with designated further products. To optimize the gimbal's performance, download the latest DJI GO app, otherwise the Zenmuse XT may not function properly.
